## About Us

Injecto Polymers Limited started its manufacturing operations of PP/HDPE Fertilizer Bags, Sugar Bags, Cement Bags / Foodgrain Bags / Rice Bags/ Sand Bags / BOPP Bags /FIBC/ Leno Bags/Shopping Bags/Pouches etc. in 2018 with an installed capacity of 5200 MT per annum. In 2021 it doubled its installed capacity to 10400 MT per annum. The plant and machinery installed are of state of the art technology with strict quality control system. The Bag manufacturing capacity is 80 lac Bags per month. Presently, the company has been supplying to reputed companies all over India.

The entire plant has been constructed on land measuring 4.65 acre in 2 phases (Phase I & II). The plant is strategically located at industrial hub of Abujhati, Burdwan, West Bengal housing many industries. The plant is also in close proximity to Haldia Petrochemicals Limited (about 200 kms), one of the major manufacturers and suppliers of HDPE/PP granules in Eastern India. Additionally, it is located approximately 460 kms from IOC Paradeep. The distance of plant from kolkata is approx 70 kms.

The sole objective of IPL is to manufacture and supply "Polyolefin (PP/HDPE) based circular woven tape based sacks required by different industries such as Fertilizers, Cement, Foodgrains, Sugar, Textiles, Chemicals & Petrochemicals etc.

The company is managed professionally with **Sri Ramesh Kumar Rateria**, Managing Director at the helm of its affairs who has an experience of over 30 years in plastic industry. The other directors are **Sri Ashok Kumar Agarwal** who has over 35 years of experience in the relevant field and he looks after marketing with **Sri Rajat Rateria**, who has over 8 years' experience and is looking after procurement and purchase, **Sri Ramanshu Rateria** is responsible for accounts and taxation. The products of the company are well established due to their superior quality and the company is steadily expanding its area of operations.
